The IFC is seeking to appoint a Consultant to assess, define, and validate the business case for a PPP model to develop of up to ten laboratories of new generation in the State of Jalisco to serve the decentralized public agencies (DPA) of the education sector at the upper secondary level with linkages to the productive sectors. The project entails the construction, operation, maintenance, and decommissioning of the laboratories (excluding provision of teaching services), while defining the location and regional vocation of each laboratory and addressing the technological change in the life of the project.
